

Pursuant to article 227 of the Consolidated Text of the Spanish Securities Market Act (*Texto Refundido de la Ley del Mercado de Valores*), FERROVIAL, S.A. (the “**Company**” or “**Ferrovial**”), reports on the following:

OTHER RELEVANT INFORMATION

We refer to the communication of other relevant information dated 24 February 2022 (registration number 14,359) regarding the buy-back programme of own shares in execution of compensation plans for Executive Directors, executives and employees of Ferrovial group, approved by the Board of Directors of the Company (the “**Programme**”).

Pursuant to articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016, supplementing Regulation (EU) No 596/2014, of the European Parliament and of the Council with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures, it is reported that during the period between 1 and 3 March 2022 the Company has carried out the following transactions over its own shares under the Programme.

Under this Programme, the Company has acquired a total of 315,000 own shares, representing c. 0.043% of Ferrovial’s current share capital.

The acquisition of own shares under the Programme has been disclosed to the market pursuant to article 2.2 of the Delegated Regulation (EU) N° 2016/1052, and has been carried out in accordance with the terms and conditions set out in this Regulation.
